The papers of the United Auto Workers Research Department Collection arrived at the Archives of Labor History and Urban Affairs between September 1969 and August 1977. Originally, the UAW transferred its non-current Research Department files from Solidarity House to its Detroit records warehouse. The Archives' staff then transferred these papers piecemeal to the Archives. The collection was opened for research use in July 1978.

The UAW Research Department (formerly the Research and Engineering Department) carries out a wide range of background investigation for the union concerning the state of the U.S. economy, trade conditions at home and abroad, the economic health of major UAW employers, technology and its impact on the work place, and general conditions on the shop floor. The UAW leadership then draws upon this research when preparing for contract negotiations, for reports to the membership, or for public policy statements. In the broadest sense, the activities of the UAW Research Department reflect the primary policy and contractual objectives of the union's leadership. They illustrate how the union reached major decisions and what sources of information it employed in formulating economic, social and political policies affecting its membership and the wider American public.

The Research Department Collection includes correspondence, statistical tables, financial reports, newsletters, news clippings, memoranda, research data, research reports, minutes of meetings, and drafts of speeches and news releases. The emphasis of the collection is largely economic, especially the Harry Chester Papers (Series III). Often the original calculations employed by the UAW in contract negotiations are found in the papers. Since the original order of these files was disrupted in their transfer from Solidarity House to the warehouse and subsequently to the Archives, the collection has been reorganized for ease of access. Subject files, for example, are simply arranged alphabetically and then chronologically within subject headings. In almost all instances, the original file labels have been retained. However, many have been expanded to provide the scholar with more detailed information on file contents.

*Given the size of the collection, the files are currently stored in Paige boxes. For similar reasons, file folders include numerous documents.

Series I, Office Files, 1938-56, Boxes 1-39.

Subseries Ia, Subject Files, 1938-56, Boxes 1-32.

This subseries includes: correspondence, financial records, memoranda, research papers, survey forms and questionnaires, drafts of speeches and reports, news clippings, statistical tables, graphs and notes. These files include some of the richest information in the collection, treating such subjects as the war effort, reconversion, women and blacks in the labor movement, discrimination, shop safety, war and post-war employment, and the general state of the U.S. economy. The subseries is arranged alphabetically by subject and then chronologically within each subject heading.

Subseries Ib, Local and Regional Office Files, 1941-52, Boxes 33-39.

This subseries includes correspondence between the Research Department and various UAW Local and Regional Offices dealing primarily with routine requests for Research Department publications or specific information. The subseries is arranged chronologically and then by Local or Region number.

Series II, Office Files, 1941-1977 (Predominantly 1956-1965), Boxes 40-64.

This series includes: correspondence, financial records, memoranda, research papers, survey forms and questionnaires, drafts of speeches and reports, news clippings, statistical tables, graphs and notes. Subjects covered in this series include: the growth of the aerospace and defense industries, automation and its impact on the industrial worker, the financial state of the auto industry, U.S. trade with Canada, higher education in Michigan, the general state of the U.S. economy, productivity, worker benefits, and the Walsh-Healy Hearings on industry. The series is arranged alphabetically by subject and then chronologically within each subject heading.

Series III, Harry L. Chester Papers, 1947-1971, Boxes 65-76.

Harry L. Chester was born in Vienna, Austria on January 17, 1912. He received training in economics, sociology, statistics, law, history, and political science at the University of Vienna and the Institute des Hautes Etudes (Paris, France). He emigrated to the U.S. in 1939 to escape the Nazis and became an American citizen in 1946. From 1948 to 1971, Harry Chester served as a UAW staff member (and later Research Associate) in the Research Department. His field of expertise was statistical problems, national accounts, and monetary and fiscal policy. The Chester papers found among

Research Department materials include his office files during his tenure with the UAW. They are primarily comprised of statistical compilations and computer print outs focusing on various economic topics (especially productivity, the consumer price index, and the guaranteed annual wage and unemployment compensation calculations). The series is arranged alphabetically by subject and then chronologically within each subject heading.

Series IV, The Big Four Auto Makers, 1930-71, Boxes 77-89.

This series includes materials pertaining to the operations of the four major auto makers: American Motor Corporation, Chrysler Corporation, Ford Motor Company and General Motors Corporation. Among the documents found in this series are: annual and quarterly reports, stock perspectuses, company releases regarding management decisions, company policies, industrial relations and productivity, sales reports, contract chronologies, wage chronologies and Research Department reports. The series is divided into four subseries by auto maker. Each subseries contains similar materials. Each is organized alphabetically by subject and then chronologically within subject headings.

books and newspapers. The photographs depicted products produced by industries employing UAW members and only rarely included pictures of individuals. All of these materials have been transferred to the Archives' photograph collection in the Audio-Visual Department. The printed materials dealt with a broad range of issues from contract negotiations to the consumer price index and from the war effort to medical insurance. Fifteen storage boxes of these materials have been transferred to the Archives' Library for inclusion in the vertical files. In addition, eleven storage boxes of duplicate contracts, formerly part of this collection, remain in the storage area on the first floor of the Archives.
