The Service Employees International Union (SEIU) placed the constitutions and by-laws of its affiliates (i.e., mostly locals) and related material in the Archives of Labor and Urban Affairs in September, 1997. The records were open for research in June 2004.

SEIU has been a continuously running international union since 1921, although it has its roots almost two decades before. In its early years, it was the Chicago-based Building Service Employees International Union, an affiliate of the American Federation of Labor (AFL), and largely organized what was then called flat janitors. Eventually, it grew to include hundreds of locals and various other affiliates throughout North America and came to organize workers in dozens of service-related fields. In 1968 it changed its name to the Service Employees International Union, reflecting its expansion into areas outside of buildings. Non professional employees working in private and public institutions employed as clericals, technicians, janitors and maintenance workers, healthcare workers, guards, doormen, and attendants of stadiums, entertainment and recreation facilities, are just a few of the venues and fields in which this union continues to organize.

Constitutions and related material comprise the bulk of this collection, although series two also contains material not limited to constitutions and by-laws.

This series is largely comprised of local union constitutions, amendments thereto and correspondence between the International and its locals. It reflects the relationships between local union officers, the secretary-treasurers office of the international and SEIU-contracted lawyers, all of whom played some role in proposing, reviewing, interpreting and approving local union constitutions.

Entries include local union numbers and date ranges of material. In rare instances, the location is listed, but only to distinguish locals that contain the same number, as SEIU occasionally recycles local numbers when a local has been dissolved or when its charter has been revoked. Box numbers are not listed on the folders because it is anticipated that this will be a growing collection so folders will invariably move into different boxes over time making the inclusion of box and folder numbers inappropriate. However, the number of folders comprising the records of a local are listed within each entry.

For those interested in knowing the local names and locations, consult the SEIU Charter Book, which lists each affiliate as well as the following pertinent information regarding that affiliate: names and dates of local union charters, mergers, dissolutions or revocations.

This series is arranged numerically by local union number. The exceptions are found in the first folder, which comprise form letters regarding constitutions and by-laws, most of which have been sent to every local affiliate and the last file comprising records of the National Union of Police Officers, an SEIU affiliate. The series is 28.5 linear feet.

This series is comprised of constitutions, amendments thereto and correspondence between the International and officers of joint and state councils, and regional conferences. It reflects the relationships between officers of these affiliates, the secretary-treasurers office of the international and SEIU-contracted lawyers, all of whom played some role in proposing, reviewing, interpreting and approving affiliate constitutions. Also contained in this series are various other records, including organizing, audit and other reports, lists of locals affiliated with joint and state councils as well as regional conferences. Also included are officer rosters, membership stats, convention agenda, programs and proceedings, charter applications, clippings, per capita tax payment stats, correspondence and other material.

Joint councils coordinate and have some jurisdiction over the activities of locals within a given portion of a state, generally a metropolitan area; whereas state councils coordinate activities and provide support to locals within a given state. Regional conferences do the same for locals within a given region. Each of these affiliates report to the International.

Box numbers are not listed on the folders because it is anticipated that this will be a growing collection so folders will invariably move into different boxes over time making the inclusion of box and folder numbers inappropriate. However, the number of folders comprising the records of these affiliates are listed within each entry.

For those interested in knowing affiliate names and locations, consult the SEIU Charter Book, which lists each affiliate as well as the following pertinent information regarding that affiliate: names and dates of affiliate charters, mergers, dissolutions or revocations.

This series begins with a folder of joint council model constitutions followed by joint council files in numerical order. Files of state and regional affiliates follow thereafter. The series is 1.5 linear feet.
